Registration Information

Starting May 19th, registration forms can be emailed to summerlearning@sd40.bc.ca. Due to the covid-19 pandemic, our office will not be accepting in-person registrations. Please use "Summer Learning 2020 Registration" as your email subject line. Registration forms can be found on our website at: newwestadulthoodlearning.ca/summer-school.

Please ensure to attach proper identification with your registration email (see below). Proper ID is mandatory as per School Act Section 82 and the BC Ministry of Education policy. We cannot register students without **all** required original documentation. Only **clear** scans or photos will be accepted.

REQUIREMENTS FOR ADULTS OVER 18

- **Proof of status in Canada:**
Canadian passport, Canadian birth certificate, Canadian citizenship card, First Nations/Metis card, Nexus card, PR card, Refugee Claimant document or valid work permit
- **Two pieces of documentation showing proof of residency (current address in BC):**
BC driver's license, BCID, BC Services card, ICBC registration, long-term tenancy agreement, property purchase agreement, utility bill (home residence), statements of insurance, income tax statement (T4), legal document indicating BC residence, bank statement or recent pay stub

Please note, we require at least one photo ID.

Note: Current (2019/2020 School Year) students of Pearson Adult Learning Centre will not have to provide documentation, as we will already have this on file.

REQUIREMENTS FOR UNDER 19 – OUT OF DISTRICT STUDENTS

- **Proof of status in Canada from BOTH parent/guardian and student:**
Canadian passport, Canadian birth certificate, Canadian citizenship card, First Nations/Metis card, Nexus card, PR card, Refugee Claimant document or valid work permit
- Photo ID from student
- **Two pieces of documentation showing proof of residency (current address in BC) from parent/guardian:**
BC driver's license, BCID, BC Services card, ICBC registration, long-term tenancy agreement, property purchase agreement, utility bill (home residence), statements of insurance, income tax statement (T4), legal document indicating BC residence, bank statement or recent pay stub
- Completed registration form with signed approval from parent/guardian **and** signed letter (on school letterhead) or email (with school signature) from school counsellor/administrator. School counsellor must indicate which courses have been approved. Incomplete registration forms will not be accepted.

REQUIREMENTS FOR UNDER 19 – NEW WESTMINSTER SCHOOL DISTRICT STUDENTS

- Completed registration form with signed approval from parent/guardian. It is important that students speak with their school counsellor to ensure proper course selection. Registration for Literacy & Numeracy 7/8/9 **must** be approved by student's school counsellor or administrator. Incomplete registration forms will not be accepted. No further documentation is required.
